The NAF has chapters in Boston, Chicago, Houston, New York, Northern California, Southern California, Washington, DC, West Michigan and the Netherlands, as well as an active alumni network, both in the Netherlands and the United States. Through our nine chapters, we organized over 70 business, cultural and social networking events.

Our Southern California Chapter organized the 16th annual three-city Princess Christina Concours classical concert tour.

In partnership with the Embassy of the Netherlands in the United States we continued to expand and maintain a comprehensive list of Dutch Researchers in the USA that was developed by the NAF in 2016.
