NAF-FULBRIGHT FELLOWSHIPS

Awarded to Dutch and American students pursuing graduate level studies at universities in each other's countries. In 2020, 9 students received NAF-Fulbright Fellowships for post-graduate studies in the Netherlands or the U.S.

SCHOLARSHIPS

Awarded to Dutch students for summer academic study and internships in Washington, DC. In 2020, five students received this scholarship.

INTERNSHIP GRANTS

Awarded to high-achieving minority and low-income Dutch students. In 2020, 18 students were awarded internship grants.

INTEREST-FREE STUDY LOANS

Awarded to Dutch students seeking to study in the United States and, on similar terms, to American students seeking to study in the Netherlands. In 2020, five Dutch and American graduate students received interest-free loans to pursue advanced studies.

J1 VISA SPONSORSHIP

In 2020, NAF continued to provide J-1 Visas for Dutch students participating in internships or traineeships in the United States.
